



## LAZYDOGS DESKTOP LICENSE

End User License Agreement for font software (EULA)

This license agreement for font software becomes a legally binding contract between you and the Büschl, Linke, Seidl GbR (henceforth referred to as »Lazydogs Typefoundry«), when you download and/or install Lazydogs Typefoundry's font software.

If you refuse to accept this agreement, you are not permitted to download or use the font software. In this case return the software to Lazydogs Typefoundry.

### 1. PERMITTED INSTALLATIONS AND USES

Subject to the terms and conditions hereof and upon complete payment of the license fee, the Lazydogs Typefoundry grants to you a perpetual, non-exclusive right to install the font software

- on up to five electronic devices (such as local workstations, laptop computers, notebooks, netbooks, tablets, mobile phones or other programmable devices with a central processing unit)
- or on a single file server for network use with up to five client devices.

All electronic devices must belong to the same company or household purchasing the font. These electronic devices can be connected to any number of output devices, such as screens, printers, plotters, exposure units etc.

Additionally you can store copies of the font software on other storage devices for archival and/or backup purposes, as long as they are not installed on these devices and this license agreement and other documentation is stored with the font software.

## LAZYDOGS WEB LICENSE

End User License Agreement for font software (EULA)

This license agreement for font software becomes a legally binding contract between you and the Büschl, Linke, Seidl GbR (henceforth referred to as »Lazydogs Typefoundry«), when you download and/or install Lazydogs Typefoundry's font software.

If you refuse to accept this agreement, you are not permitted to download or use the font software. In this case return the software to Lazydogs Typefoundry.

### 1. PERMITTED INSTALLATIONS AND USES

Subject to the terms and conditions hereof and upon complete payment of the license fee, the Lazydogs Typefoundry grants to you a non-exclusive, non-transferable right to use the font software on websites, using the @font-face selector in CSS files, subject to all of the following:

- The licensed font software may be used on any website owned by you. The total traffic, measured in page views, of all websites using the licensed font software must be no greater than 100,000 page views per month. If the total traffic exceeds this limit, you must contact Lazydogs Typefoundry.

## APPENDIX – HOW TO PREVENT DIRECT-LINKING

As described in the EULA for web fonts delivered with your product you have to prevent direct-linking of our font files. This means, that a user can't simply access the url to your website's font folder and download all font files, or link to the fonts for use in another website.

Here is how to do it:

1. Create a .htaccess file as described below. Replace **example.com** by your own host name while the dot must be preceded by a backslash.
2. Place the .htaccess file in the same folder on your server where the font files are in.

### More about htaccess

The .htaccess file is usually a common plain text file. Content of the file should be:

```

Be aware that this depends on how your hosting service is handling .htaccess file properties. Note that you have to have proper user and file permissions for the server. Uploading and generating the .htaccess file requires ftp access, common user permissions, file permissions and at least some kind of ftp client program.

This is what happens through this file:

Requests for all font files (coming from a site other than your own) will now receive an HTTP error 403 («forbidden»).

The line `Options -Indexes` disables the file listing for the fonts directory.

If you are not familiar with .htaccess or your hosts restrictions about this, you will most likely find further information on your hosts website.
